Demographic Profile

The population in the Midlands was 739,836 per American Community Survey data for 2018-2022.

The region has a civilian labor force of 373,830 with a participation rate of 64.0%. Of individuals 25 to 64 in the Midlands, 38.9% have a bachelor's degree or higher which compares with 36.5% in the nation.

The median household income in the Midlands is \$66,715 and the median house value is \$217,991.



Employment Trends


As of 2024Q3, total employment for the Midlands was 389,152 (based on a four-quarter moving average). Over the year ending 2024Q3, employment increased 1.8% in the region.

Unemployment Rate


The unemployment rate for the Midlands was 3.9% as of December 2024. The regional unemployment rate was the same as the national rate of 3.9%. One year earlier, in December 2023, the unemployment rate in the Midlands was 2.8%.



Unemployment rate data are from the Local Area Unemployment Statistics, provided by the Bureau of Labor Statistics and updated through December 2024.

Wage Trends

The average worker in the Midlands earned annual wages of \$57,960 as of 2024Q3. Average annual wages per worker increased 3.4% in the region over the preceding four quarters. For comparison purposes, annual average wages were \$72,609 in the nation as of 2024Q3.



Annual average wages per worker data are derived from the Quarterly Census of Employment and Wages, provided by the Bureau of Labor Statistics and imputed where necessary. Data are updated through 2024Q2 with preliminary estimates updated to 2024Q3.

Cost of Living Index

The Cost of Living Index estimates the relative price levels for consumer goods and services. When applied to wages and salaries, the result is a measure of relative purchasing power. The cost of living is 10.5% lower in Midlands than the U.S. average.



Industry Snapshot

The largest sector in the Midlands is Health Care and Social Assistance, employing 57,057 workers. The next-largest sectors in the region are Retail Trade (40,849 workers) and Accommodation and Food Services (34,927). High location quotients (LQs) indicate sectors in which a region has high concentrations of employment compared to the national average. The sectors with the largest LQs in the region are Public Administration (LQ = 1.80), Finance and Insurance (1.60), and Utilities (1.40).

Employment data are derived from the Quarterly Census of Employment and Wages, provided by the Bureau of Labor Statistics and imputed where necessary. Data are updated through 2024Q2 with preliminary estimates updated to 2024Q3.

Sectors in the Midlands with the highest average wages per worker are Utilities (\$106,339), Management of Companies and Enterprises (\$95,226), and Professional, Scientific, and Technical Services (\$88,443). Regional sectors with the best job growth (or most moderate job losses) over the last 5 years are Health Care and Social Assistance (+4,023 jobs), Professional, Scientific, and Technical Services (+3,803), and Transportation and Warehousing (+2,563).

Over the next 1 year, employment in the Midlands is projected to expand by 2,826 jobs. The fastest growing sector in the region is expected to be Health Care and Social Assistance with a +1.2% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Health Care and Social Assistance (+688 jobs), Accommodation and Food Services (+283), and Professional, Scientific, and Technical Services (+236).

Occupation Snapshot

The largest major occupation group in the Midlands is Office and Administrative Support Occupations, employing 52,480 workers. The next-largest occupation groups in the region are Sales and Related Occupations (36,756 workers) and Food Preparation and Serving Related Occupations (33,956). High location quotients (LQs) indicate occupation groups in which a region has high concentrations of employment compared to the national average. The major groups with the largest LQs in the region are Legal Occupations (LQ = 1.52), Protective Service Occupations (1.49), and Healthcare Practitioners and Technical Occupations (1.18).

Occupation groups in the Midlands with the highest average wages per worker are Management Occupations (\$117,700), Healthcare Practitioners and Technical Occupations (\$99,800), and Legal Occupations (\$96,300). The unemployment rate in the region varied among the major groups from 1.3% among Legal Occupations to 7.2% among Farming, Fishing, and Forestry Occupations.

Over the next 1 year, the fastest growing occupation group in the Midlands is expected to be Healthcare Support Occupations with a +1.6% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Transportation and Material Moving Occupations (+314 jobs) and Healthcare Practitioners and Technical Occupations (+313). Over the same period, the highest separation demand (occupation demand due to retirements and workers moving from one occupation to another) is expected in Food Preparation and Serving Related Occupations (6,650 jobs) and Office and Administrative Support Occupations (5,840).



Industry Clusters

A cluster is a geographic concentration of interrelated industries or occupations. The industry cluster in the Midlands with the highest relative concentration is Pharmaceutical with a location quotient of 2.06. This cluster employs 1,691 workers in the region with an average wage of \$87,257. Employment in the Pharmaceutical cluster is projected to expand in the region about 1.1% per year over the next ten years.

Industry Clusters for Midlands as of 2024Q3



Education Levels

Expected growth rates for occupations vary by the education and training required. While all employment in the Midlands is projected to grow 0.7% over the next ten years, occupations typically requiring a postgraduate degree are expected to grow 0.9% per year, those requiring a bachelor's degree are forecast to grow 1.0% per year, and occupations typically needing a 2-year degree or certificate are expected to grow 0.8% per year.


Annual Average Projected Job Growth by Education Levels

Gross Domestic Product

Gross Domestic Product (GDP) is the total value of goods and services produced by a region. In 2023, nominal GDP in the Midlands expanded 7.3%. This follows growth of 6.1% in 2022. As of 2023, total GDP in the Midlands was \$51,156,617,000.

Of the sectors in the Midlands, Real Estate and Rental and Leasing contributed the largest portion of GDP in 2023, \$6,385,885,000 The next-largest contributions came from Health Care and Social Assistance (\$5,696,570,000); Finance and Insurance (\$4,511,615,000); and Manufacturing (\$4,091,177,000).



FAQ

What is a location quotient?

A location quotient (LQ) is a measurement of concentration in comparison to the nation. An LQ of 1.00 indicates a region has the same concentration of an industry (or occupation) as the nation. An LQ of 2.00 would mean the region has twice the expected employment compared to the nation and an LQ of 0.50 would mean the region has half the expected employment in comparison to the nation.

What is separation demand?

Separation demand is the number of jobs required due to separations—labor force exits (including retirements) and turnover resulting from workers moving from one occupation into another. Note that separation demand does not include all turnover—it does not include when workers stay in the same occupation but switch employers. The total projected demand for an occupation is the sum of the separation demand and the growth demand (which is the increase or decrease of jobs in an occupation expected due to expansion or contraction of the overall number of jobs in that occupation).

What is a cluster?

A cluster is a geographic concentration of interrelated industries or occupations. If a regional cluster has a location quotient of 1.25 or greater, the region is considered to possess a competitive advantage in that cluster.

What is the difference between industry wages and occupation wages?

Industry wages and occupation wages are estimated via separate data sets, often the time periods being reported do not align, and wages are defined slightly differently in the two systems (for example, certain bonuses are included in the industry wages but not the occupation wages). It is therefore common that estimates of the average industry wages and average occupation wages in a region do not match exactly.

What is NAICS?

The North American Industry Classification System (NAICS) is used to classify business establishments according to the type of economic activity. The NAICS Code comprises six levels, from the "all industry" level to the 6-digit level. The first two digits define the top level category, known as the "sector," which is the level examined in this report.

What is SOC?

The Standard Occupational Classification system (SOC) is used to classify workers into occupational categories. All workers are classified into one of over 804 occupations according to their occupational definition. To facilitate classification, occupations are combined to form 22 major groups, 95 minor groups, and 452 occupation groups. Each occupation group includes detailed occupations requiring similar job duties, skills, education, or experience.
